# 1. PAYMENT

All monies should be paid directly to Artist or Artist's designated representative prior to the final performance or after the show but no later than 14 days in currency agreed between both parties. If there is an assessment of tax by any taxing authority on Artist for any monies earned during the performance, said tax is to be paid by Purchaser. It is fully agreed and understood that no deductions whatsoever are to be taken from contract price or from any percentage hereunder earned.

Payment conditions are subject to Ellite Records and Purchaser separate agreement and they may vary depending on the particular engagement.

# 2. BILLING/OTHER ARTISTS

The correct billing for Artist, applicable in all promotional materials shall be: MICHAŁ WRÓBLEWSKI TRIO

# 3. TRANSPORTATION/HOTEL

All hotel accommodations will be in a at least 3-STAR hotel near the place of performance. If hotel accommodations are not included in the contract, Purchaser agrees to provide four (4) single rooms nightly for the entire engagement.

The hotel information should be emailed to **management@elliterecords.pl** prior to confirmation for approval (to be forwarded to the Artist).

## 4. SETUP/REHEARSAL

On the day of performance, the place of the performance will be made available to the Artist for technical setup and rehearsal at the time agreed between Artist and Purchaser. Purchaser will provide a house electrician and house sound technician at that time.

# 5. DRESSING ROOMS/SECURITY

A dressing room adequate for use by four (4) people during the Artist's entire performance. Said room shall be clean and heated. These dressing rooms shall have easy access to clean lavatories, be locked or suitably secure and contain Spring Water for the Artists. Festival situation: HOT MEAL – If not mentioned otherwise, hot meals need to be provided each night of the engagement.

#### 6. ANCILLARY SALES

Purchaser agrees to provide the Artist with adequate space (and if necessary a sales person) for the Artist or his representative to sell recordings at the place of performance. It is further understood that the Artist retains the sole and exclusive right to sell such material.

#### 7. COMPLIMENTARY TICKETS

Upon request, Purchaser will provide the Artist with 8 (8) complimentary tickets nightly.

## 8. RECORDING/PHOTOGRAPHY

There will be no Audio recordings, video recordings or radio broadcasts during said performance unless prior written permission is granted by Artist or Artist's representative. If stated otherwise, the contract will include exploitation fields of any registered material. There will be no flash photography of Artist during said performance.

## 9. MISCELLANEOUS

**Artist has 100% control of performance.** Artist shall not be required to perform before any audience which is segregated on the basis of race, creed or color, national origin, age, disability or sexual preference.

Artist's obligations hereunder are subject to detention or prevention by sickness, inability to perform, accident, transportation delays, acts of God, labor difficulties, epidemics or any act or order of public authority or any other cause, similar or dissimilar, beyond Artist's control.

# 10. SOUND/MUSICAL EQUIPMENT SUPPLIED BY PURCHASER

**PIANO\*** - grand piano (preferably Yamaha/Steinway) **DOUBLE BASS** - own instrument, bassist has his own pick-up & amplifier - combo **DRUMS** - own instrument; stage space minimum 3 x 2,5 m2 (if possible - drumset at the Venue)
