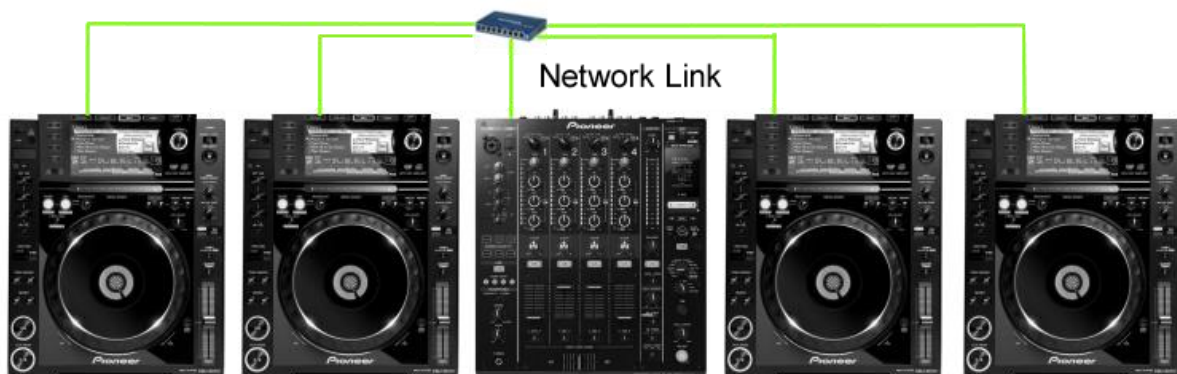

## TECHNICAL SPECIFICATION

The following technical rider is a MINIMUM specification, if these specifications are not met this will result in NO PERFORMANCE.

## DJ REQUIREMENTS

Setup must meet the following:



- One (1) Pioneer DJM-900 NEXUS (DJM-900NXS) DJ mixer or better
- Four (4) Pioneer CDJ-2000 NEXUS (CDJ-2000NXS), linked via Ethernet hub
- Two (2) monitor speakers – adjustable through mixer (no Consumer Equipment like HK Audio, IMG-Stageline or similar)
- One (1) wireless sennheiser Microphone or similar, connected via the mixer

It is absolutely necessary that the CDJ's have fully functional USB ports.

## RIDER AND SETUP INSTRUCTIONS

All equipment must be in full working condition without any defects and with presence of full connection which allows usage of all functions.

A professionally trained sound engineer on site for the entire set.

Sound system must be up to the industry standards (loud enough for the size of the room, clear sound, no sound bleed from other stages or rooms).

Artist reserves the right to have people removed from the stage during the performance.

If the requirements of this Technical Rider are not fulfilled, the artist is entitled to cancel the performance at any time. The organizer and / or contractor are not entitled to any compensation claims.

The stage must be stable and secured according to current regulations. If the artist suspects that the applicable industry and safety standards have not been met or neglected and / or the equipment should be in an unacceptable or defective condition, he may cancel the performance without being regressed.

## SECURITY

The organizer and / or contractor is responsible for the safety of the luggage and equipment brought by the artist and accordingly has to provide sufficient security or lockable rooms.

## SOUND CHECK

A Soundcheck is only needed if the artist acts as an opening act. In all other cases the continuous operation of the sound system as soundcheck is sufficient.

## ACCOMMODATION

Hotel Room with a king size bed and late check out. Breakfast and free internet access included.

## HOSPITALITY

The following must be provided to the artist free of charge:

1 x hot meal or \$50 dinner buyout

6 x bottled water & 2 x sweat towel

## OTHER REQUIREMENTS

- Transportation to and from airport and venue must be provided.

If the organizer and / or bokker is unable to provide transportation cab fare has to be provided.

## DECLARATION

I understood that any non-fulfillment of the requirements will inevitably lead to a termination of the performance.

All liability and damage claims are limited to the order value. Property damage in the Equipment and equipment or other durable goods are repaired at the expense of the one who

has caused or caused. By signing the application, each contractor accepts the disclaimer

the artist for injuries and damages of any kind that may arise from participation in the event. Liability

for lost items is also taken over by the contract partner.

Final provisions / Severability clause

Jurisdiction for all obligations or disputes arising from the contract is Arnsberg. It is the law of the Federal Republic

Germany. Should individual provisions of this contract be ineffective or unenforceable or after the conclusion of the contract

become ineffective or impracticable, this shall not affect the validity of the remaining provisions. Instead of

Ineffective or impracticable provision shall be that effective and enforceable provision whose Effects of the economic objective which comes as close as possible to the contracting parties with the ineffective

or unenforceable provision. The above provisions apply accordingly in the event that the contract turns out to be incomplete.
